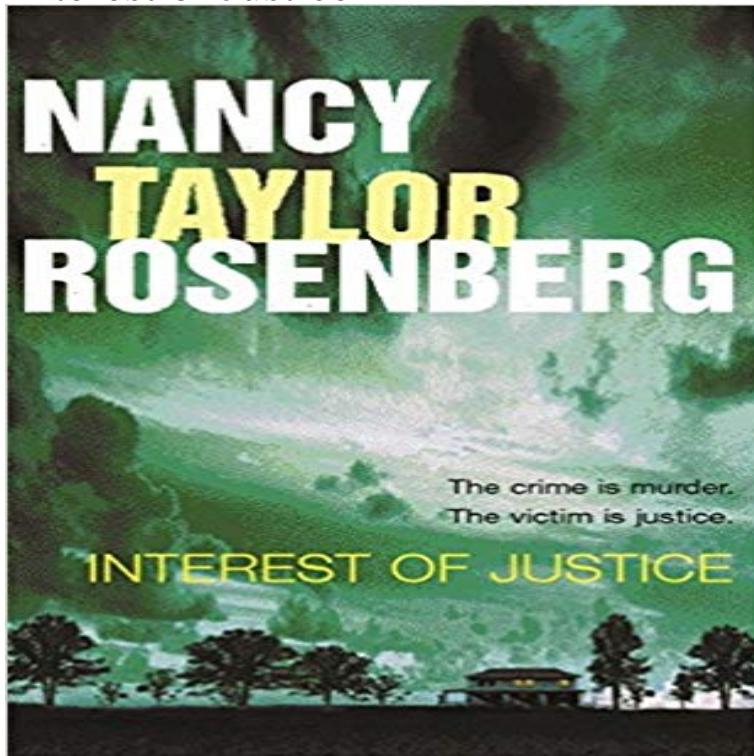


## Interest of Justice
