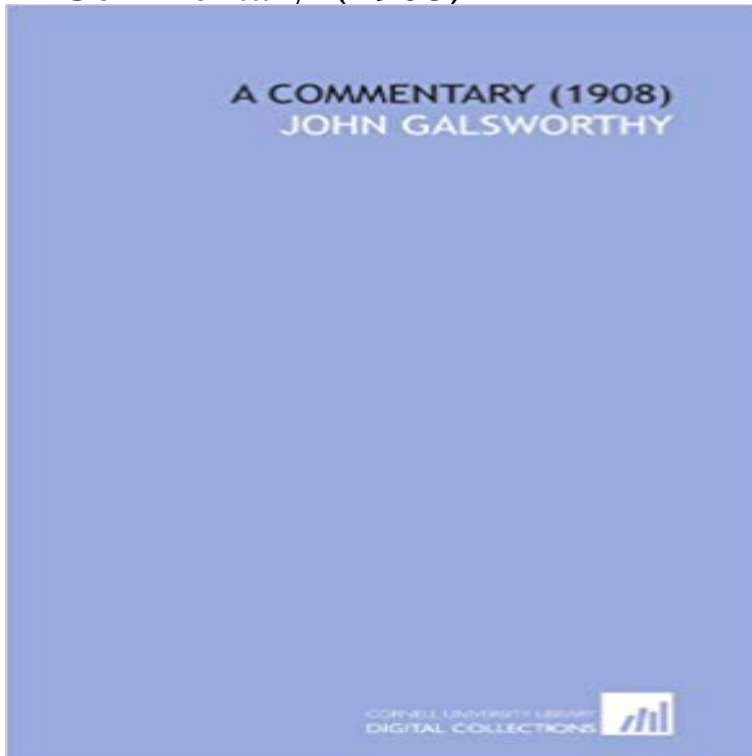


## A Commentary (1908)
